Complaint

I, Thomas L. Wolfe, of Liberty Township, Clinton County, Iowa, being of sound and disposing mind and memory, do make declare and publish this my last will and testament, hereby revoking any and all former wills by me made.

I direct my executor herein named to pay all of my just debts including the costs of administration.

I give devise and bequeath to each of my four children, namely, Thomas E. Wolfe, Ellen L. Wolfe, Cornelius Wolfe and Francis Leo Wolfe all of my property both real and personal in equal shares, share and share alike after the death of myself and my wife Catherine Wolfe should she survive me.

I give, devise and bequeath to my wife Catherine Wolfe, should she survive me the net income of my farm each and every year to the end of her life which shall be what is left after first paying the interest, taxes, insurance, and keeping up the necessary repairs on the farm each year. This my will that she and my son Cornelius Wolfe shall

run the farm the same as he, and I am now running it, that is one-half of all stock and crops is to be mine and one-half to be his of the net earnings each year, as he now owns one-half and I own one-half of the stock and crops. And whenever my son Cornelius and my wife Catherine desire to stop this manner of running the farm, the one-half that belongs to my estate shall be sold and applied on the debt against my farm and the farm is to be rented to what seems the best advantage, and the proceeds as herein before directed, and my executor herein named shall attend to the rents and income and apply the same each year as herein directed.

I herein name as sole executor of this my last will and testament my son Cornelius Wolfe and I exempt him from giving any bond and security, as such and he shall attend to all the business matters so that it shall be to the best advantage of the estate, and he shall if it becomes necessary renew the mortgage against the place to the best advantage and lowest rate of interest obtainable locally.
